

CONDITIONS

Refund or cancellation is to be made if requested by the customer, but only if any and after The Bank having received confirmation from its foreign correspondent of effective cancellation of the remittance and in the case of funds already converted into foreign currencies by the Bank or its correspondents, refund is to be made only on the basis of the amount actually received from the correspondents and The Bank's buying rate on the day of refund.
5. The Bank is entitled to reimbursement for the expenses of The Bank, its correspondents and agents.
6. Cheques accepted for reimbursement will be subject to final realization.
